Entries

The entry fee for a 10' x 10' space is \$100 for the Festival. Please make check payable to Historic Warehouse District.

Please fill out the entry form and mail to "Art Show, Historic Warehouse District", 1010 Euclid Ave, 3rd Floor, Cleveland, OH 44115, along with at least one image of your booth and three images of your artwork.

Deadline: First Jury held on February 27, 2016. Additional Juries will be held until the show is filled.

Categories of Art Work

Oil, watercolor, acrylic painting, pastels, ink, photography, textiles, weaving, soft sculpture, pottery, glass, ceramics, woodworking, jewelry, leather, and other materials

Important Information

- All work must be original or handcrafted. Nothing commercial.
- Multiple originals or series of artworks, created by the artist, using usual and customary production methods for that media type are accepted as original art.
- We reserve the right to remove objectionable art from your exhibit.
- Each Exhibitor will be responsible for his/her own display area to fit within a 10-foot by 10-foot space and be strong enough to withstand the elements. This includes chairs, tables, setups, signs, weather protection, proper screening of cartons and extra materials. (If requested in advance, tables may be rented for a nominal fee.)

Although the space for the tent is 10 x 10, there is opportunity to come out in front of, or next to, the tent space. Plus, we are willing to discuss your special needs, and if you **MUST** have additional space, please advise us in advance.

- All tents must be weighted. No exceptions.
- All Exhibitors are required to carry their own liability insurance as the Festival assumes no liability for damage, theft or injury on or off exhibit premises.
- Each Exhibitor will be responsible for his/her own sales receipts and sales tax.
- Exhibitors are responsible for procuring a Cuyahoga County vendor's license. Licenses may be obtained by contacting the Cuyahoga County Auditor's office at 216-443-7100.
- The Festival begins at noon. You may set-up your booth any time after 9 a.m.

However, your booth must be completely set-up and prepared for sales no later than noon. No vehicles will be permitted to drive down the street after 11 a.m. After that time, please be prepared to move your display and inventory by hand or two-wheeler. No booth may be dismantled before 8 p.m. on Sunday.

If you require additional set-up time, please advise us so that special arrangements may be made.

- Prior to the event, artists will receive additional details, parking information and promotional materials.
- In order to encourage sales and add interest to the event, the Festival welcomes live demonstrations by Exhibitors. Feel free to discuss ideas with Marcia Mandell. It is possible that you may receive a reduced booth fee or larger booth space in exchange for an art demonstration.
- We regret that there can be no refunds or cancellations.

A comprehensive promotional campaign to promote the Festival is planned in area newspapers, magazines, television and radio.
