## Event Guidelines – For Your Records

1. A copy of your Insurance & Health Department Inspection required with application for consideration.
2. Enclose a self addressed, stamped envelope with enough postage to return materials submitted along with acceptance notification (two first class stamps). All others will be notified by e-mail.
3. Refunds will be issued until December 20, 2017 less handling charges of \$50.00. Requests for withdrawal must be made in writing & postmarked by December 20, 2017 for consideration. After that date refunds or show credits will not be issued for any reason.
4. Trucks may set up a pop up tent in addition to the licensed truck. Exhibitor is responsible for providing their own tables, chairs and other props unless indicated otherwise on their application. Outside exhibitors must use a tent. If outside, you may bring a generator with you to light or heat your space.
5. Trucks will park near the Arts & Crafts Building.
6. Overnight camping is available for additional fees.
7. Exhibitors are asked to keep their area clean of debris.
8. Exhibitors may set up on Friday afternoon or on Saturday morning. Details sent with confirmations.
9. Trucks may use their own generators, or access electricity on the outside poles in front of the Arts & Crafts Building. Electrical outlets are 110. If something is needed, please check ahead of time for availability.
10. Exhibitors are responsible for removing unsold merchandise at the close of business on on either Sunday, January 28 or Monday, January 29, 2018.
11. Exhibitors are expected to stay until 3:00 pm on Saturday & Sunday.

Northcoast Promotions, Inc., The Cuyahoga County Fairgrounds, and the Polar Fest Committee, their staff, agents, representatives, and volunteers will not be held responsible for any lost, stolen or damaged property of exhibitors, their representatives, customers, or any other person and/or damage or injury to any person participating in this event for any reason.
