## Vendor Terms & Conditions

**Hours of operation:** Event begins at 5 pm on Friday & remain open until 9pm the day of the event.

**Set Up & Tear Down:** Ramp Level: one flight of stairs. Early set up on the Thursday before event date scheduled between 6:00 – 8:00 pm. Friday set up begins at 2:00pm – 4:45pm. Booths ready for business by 5:00pm. Exhibitors may begin tear down beginning at 9:05 pm. Location in building may change from month to month.

**Booth Size:** Single booth sizes are at least 8' x 6'. If event is undersold, more space will be granted. Artists may rent tables & chairs from the building for additional fees. See page one for details on costs. Please come prepared with tables, chairs, display racks for proper display of art work. Tables & displays must fit within space allotted.

**Lighting & WiFi:** Lighting is not consistent & there may be dark areas within space. Everyone has access to electricity, but may need extension cords/surge protectors to use. There isn't access to WiFi, please bring hot spot to connect if needed for sales.

**Images:** Please submit three (3) images representing work and one (1) of booth set up.

**Booth Fees:** Must be remitted on or before the first week of the month of participation with this form prior to the event. We are no longer collecting day of show.

**Trash:** Space must be free of trash at all times.

**Vendors License & Sales Tax:** All exhibitors must have an Ohio vendors or business licenses to participate. Vendors are responsible for collection & payment of applicable sales taxes. You DO NOT need the City of Cleveland ID badge at this event.

**Cancellations:** No refunds or show credits will be made for cancellations or early departures for any reason.

**Access:** Vendors may not block isles designated for access to resident artist hung works or building tenants entrances.
