2. Exhibitor space will be determined according to (1) your craft/company you represent and (2) the order in which contracts are received. To ensure diversity in this show, please be specific in the description of your craft. Every effort will be made to separate similar products.
3. Any crafts/merchandise displayed that have not received prior approval will be subject to the craft show committee and Northcoast Promotions discretion. Exhibitors displaying items not approved may be asked to put them away, or be asked to leave without refund.
4. Northcoast Promotions will try to limit the amount of any craft to ensure diversity.
5. Candy /fudge / baked goods are permitted as long as exhibitor follows Ohio Law on labeling. Some foods may require a licensed kitchen to sell to the public. If you have questions, please contact us.
6. Exhibitors are asked to donate one small raffle item.
