Eligibility Criteria

Eligibility criteria for the show are determined by the Viva Bavaria Committee.

The following criteria must be met:

- Work must show originality
- Work must be produced by the applicant or applicants
- Work which is one-of-a-kind or of a unique medium is strongly encouraged
- Searching for hand crafted works produced by artisan present at event

The following criteria describe unacceptable work:

- Commercially purchased finished products

Process

- Makers, Crafters and Artisans submit four images of their work, plus one booth set up.
- Digital images only.
- Applications must describe works submitted.
- Include an additional photograph of your booth. All booths must be attractive and allow entrance and exit without relying on your neighbor's space.
- No stored items may be visible during the show.
- Retail prices and appropriate labeling for your product are required and should be included with your jury submission.
- Letters explaining the results of the jury will be e-mailed within one week of the jury.
- We limit the number of makers, crafters and artisans in each category but waiting lists are maintained if your category is currently filled.
- If your work is not accepted, we will offer suggestions and feedback that may be helpful in order to reapply. You are eligible to jury once a year.

Details

1. Application accepted until October 1, 2021.
2. When applicant is accepted into Christkindlmarkt 50% non-refundable deposit is due (\$75 for single booth/\$150 for double booth) to secure space within 30 days of notification of acceptance. All remaining fees are due/paid in full by October 1, 2021 to participate.
3. Refunds will not be issued once accepted.
4. All participants must have a valid Ohio Sales Tax number to participate and are responsible for all taxes due.
5. Exhibitors are responsible for providing their own canopies/tents, tables, chairs, lighting and other props. If rentals need to be secured, it is the responsibility of the exhibitor to rent & pay for any rentals.
6. Exhibitors are required to have white tents/canopies.
7. White lights only on outside of canopy is optional.
8. Decorations on the outside of the tent/canopy may only be Christmas green, hunter green, Christmas red and/or burgundy
9. Exhibitors are asked to keep their area clean of debris.
10. Exhibitors are required to stay open until 8 pm.
11. Exhibitors are responsible for removing unsold merchandise, tents/canopies, tables, props by 11 pm, Saturday, December 4, 2021.
12. All booths must provide own ABC fire extinguishers.
13. Viva Bavaria, German Central and Northcoast Promotions, Inc., their staff, agents, representatives, and volunteers will not be held responsible for any lost, stolen or damaged property of exhibitors, their representatives, customers, or any other person and/or damage or injury to any person participating in this event for any reason.
